



AppSpots Terms of Service

Thanks for using our products and services (“Services”). The Services are provided by Sensus B.V. (“AppSpots”), located at Oudezijds Kolk 5A 1012AL Amsterdam, Netherlands.

By using our Services, you are agreeing to these terms. Please read them carefully.

Our Services are diverse so sometimes additional terms or product requirements may apply, such as Wireless Network Terms of Use. Additional terms will be available with the relevant Services, and those additional terms become part of your agreement with us if you use those Services.

Using our Services

You must follow any policies made available to you within the Services.

Don’t misuse our Services. For example, don’t interfere with our Services or try to access them using a method other than the interface and the instructions that we provide. You may use our Services only as permitted by law, including applicable export and re-export control laws and regulations. We may suspend or stop providing our Services to you if you do not comply with our terms or policies or if we are investigating suspected misconduct.

Using our Services does not give you ownership of any intellectual property rights in our Services or the content you access. All claims arising out of or relating to these terms or the Services will be litigated exclusively by the court at Haarlem in Netherlands, and you and AppSpots consent to personal jurisdiction in those courts.
